Data Protection Policy

Definitions

GDPR	The UK General Data Protection Regulation
Responsible Persons	Silverback's Data Protection Officer and Data Handler
Register of Systems	A register of all systems or contexts in which personal data is processed by Silverback Security Academy
Relevant Regulations	UK GDPR and the <u>Data Protection Act 2018</u> and the <u>Equality Act 2010</u> .

1. Data protection principles

Silverback Security Academy (herein known as Silverback) is committed to processing data in accordance with its responsibilities under the UK GDPR.

Article 5 of GDPR requires that personal data shall be:

- a. Processed lawfully, fairly and in a transparent manner in relation to individuals
- b. Collected for specified, explicit and legitimate purposes and not further processed in a manner that is incompatible with those purposes; further processing for archiving purposes in the public interest, scientific or historical research purposes or statistical purposes shall not be considered to be incompatible with the initial purposes
- c. Adequate, relevant and limited to what is necessary in relation to the purposes for which they are processed
- d. Accurate and, where necessary, kept up to date; Silverback ensures every reasonable step is taken to ensure that personal data that are inaccurate, having regard to the purposes for which they are processed, are erased or rectified without delay;
- e. Kept in a form that permits identification of data subjects for no longer than is necessary for the purposes for which the personal data are processed;

personal data may be stored for longer periods insofar as the personal data will be processed solely for archiving purposes in the public interest, scientific or historical research purposes or statistical purposes subject to implementation of the appropriate technical and organisational measures required by the GDPR in order to safeguard the rights and freedoms of individuals, and

- f. Processed in a manner that ensures appropriate security of the personal data, including protection against unauthorised or unlawful processing and against accidental loss, destruction or damage, using appropriate technical or organisational measures.

2. General provisions

- a. This policy applies to all personal data processed by Silverback
- b. The Responsible Persons shall take responsibility for Silverback's ongoing compliance with this policy
- c. This policy shall be reviewed at least annually
- d. Silverback shall maintain its registration with the Information Commissioner's Office as an organisation that processes personal data – current registration no. ZA367807.

3. Lawful, fair and transparent processing

- a. To ensure its processing of data is lawful, fair and transparent, Silverback shall maintain a Register of Systems
- b. The Register of Systems shall be reviewed at least annually
- c. Individuals have the right to access their personal data and any such requests made to the academy shall be dealt with in a timely manner.

4. Lawful purposes

- a. All data processed by Silverback must be done on one of the following lawful bases: consent, contract, legal obligation, vital interests, public task or legitimate interests ([see ICO guidance for more information](#))
- b. Silverback shall note the appropriate lawful basis in the Register of Systems
- c. Where consent is relied upon as a lawful basis for processing data, evidence of opt-in consent shall be kept with the personal data
- d. Where communications are sent to individuals based on their consent, the option for the individual to revoke their consent should be clearly available and systems should be in place to ensure such revocation is reflected accurately in Silverback's systems.

5. Data minimisation

- a. Silverback shall ensure that personal data are adequate, relevant and limited to what is necessary in relation to the purposes for which they are processed
- b. Only personal data relevant to Silverback programmes are processed
- c. Personal data collected from the Silverback website shall be supported by a Privacy Policy and a Cookie Policy, that are available to be viewed by website visitors.

6. Accuracy

- a. Silverback shall take reasonable steps to ensure personal data is accurate
- b. Where necessary for the lawful basis on which data are processed, steps shall be put in place to ensure that personal data are kept up to date.

7. Archiving / removal

- a. To ensure that personal data are kept for no longer than necessary, Silverback shall put in place an archiving policy for each area in which personal data are processed and will review this process annually
- b. The archiving policy shall consider what data should/must be retained, for how long, and why.

8. Security

- a. Silverback shall ensure that personal data are stored securely using modern software that is kept-up-to-date
- b. Access to personal data shall be limited to personnel who need access and appropriate security should be in place to avoid unauthorised sharing of information
- c. When personal data are deleted this should be done safely such that the data is irrecoverable
- d. Appropriate back-up and disaster recovery solutions shall be in place.

9. Breach

In the event of a breach of security leading to the accidental or unlawful destruction, loss, alteration, unauthorised disclosure of, or access to, personal data, Silverback shall promptly assess the risk to individual's rights and freedoms and if appropriate, report this breach to the ICO ([more information on the ICO website](#)).
